Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.gentlewhiskbakery.com and The Vegan Beggar's Kitchen, LLC (DBA Gentle Whisk Bakery) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Gentle Whisk Bakery include, The Vegan Beggar's Kitchen LLC, Gentle Whisk Bakery and www.gentlewhiskbakery.com. The Gentle Whisk Bakery website is a baked good sales site. By using the Gentle Whisk Bakery website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our site, Gentle Whisk Bakery may collect personally identifiable information, such as your:

- -First and Last Name
- -Mailing Address
- -E-mail Address
- -Phone Number

If you purchase Gentle Whisk Bakery's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Use of your Personal Information

Sharing Information with Third Parties

Gentle Whisk Bakery does not sell, rent or lease its customer lists to third parties. Gentle Whisk Bakery may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Gentle Whisk Bakery, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

-SSL Protocol

- •Comply with the California Electronic Communications Privacy Act;
